In the name of God the Compassionate the Merciful

- 1- The establishment of a relief committee at Al Musa well by exempting the turn of six truckloads from Jurat al Kharkhur and selling the turns in an auction, and then distributing the profits among the poor and the needy.
- 2- During the drop of oil prices, some of the truck drivers refused to fill up oil, claiming they are not making profit. After a short period, the price of oil went up and the drivers came back. The brothers in that sector issued penalties of 50 to 100 USD for the drivers who refused to fill up oil earlier, when the price dropped. More than 50 individuals were penalized.
- 3- Six exempted turns were donated by brother Abu-Hamzah al-Shami on 18/05/1436 Hijri [09 MAR 2015.] We recovered the profits from the individuals of these special turns.
- 4- After we received complaints from truck owners claiming that they were unjustly treated when they were weighing their trucks using the current methods, we supervised the unloading of their tanks into a cubical storage tanks in order to verify the actual number of barrels per load. The issue of shortages and surpluses of the trucks has been addressed before.
- 5- We monitored the staff of the oil wells to assure their adherence to prayers, good ethics, and no-smoking rules; we are holding them responsible for violations, although we found out that the majority of the staff at Al Musa well are smokers.
- 6- While conducting a tour of Abu Nurah oil well, and after auditing the books of arrival times and oil loading turns, we found two out-of-line vehicles that were serviced. After investigating the matter, we found out that the accountant of the facility gave the orders for these two vehicles to bypass the line. We arrested the staff who are responsible for this act and placed them in jail.
- 7- After receiving numerous complaints about the convoys at Al Fayyad oil well, brother Abu-Hibah al-Maghribi conducted a confirmation and we found many listed fictitious names of non-

existing individuals. We arrested the official in charge of assigning turns – Hayil ‘Ubayd al-Muhammad – and placed him in jail.

8- We arrested Abu-'Umar Fawzi of Al Husayn village, the former coordinator of oil-loading turns at Al Musa oil well, after fleeing his position because he was altering the oil-loading turns for his personal benefits. After his release from prison and through our investigation, we found out that Abu-'Umar owns a Mercedes tanker and a Kia 4000 vehicle.

9- We helped brother Abu-Hibah al-Maghribi to arrest the rest of the cell at Al Husayn village.

10- We placed well-trusted individuals to inform us with what is happening at the oil wells.

11- Ordinary local people have been appointed to supervise the purchase of fuel, motor oil, and spare parts, and to conduct repair and maintenance work on all oil wells in the Sector, and to submit receipts of their work.

12- On Wednesday 18/06/1436 Hijri [08 APR 2015] while conducting a patrol in the Sector and at Al Musa oil well area, we found the guards at the well in a state of confusion because the brothers from the Islamic Police in As Sur raided the oil well facility after receiving a complaint by Sayf-al-'Askar, a member of the local community who has tankers at the well. Sayf-al-'Askar and the Islamic Police attacked and cursed Abu-Mustafa, the turn coordinator at the well, and hit Abu-al-Tayyib, the coordinator of the nearby Ad Dahsh well. The attackers falsely accused the coordinators of being conspirators, accepting bribes from drivers, and discriminating against the drivers for personal enmity.

The attackers committed their actions knowing that no one can attack or interfere with the activities of the oil wells or their workers without coming to us first. We immediately went to the Islamic Police station at As Sur, accompanied the officials of the sector to investigate this case and put an end to these acts, and to warn the brothers not to repeat them. We arrested the petitioner Sayf-al-'Askar and imprisoned him for three days then we referred him to the Islamic court.

13- We arrested three workers from the staff of Ad Dalala oil well who were allowing a truck owner to fill up his truck for free every week and to sell the oil without keeping records or receipts. This theft went on for two months before we discovered it. We arrested the cell members and put them in jail. They were fined by the prosecutor brother.

14- We arrested the staff of Al Faysal group oil well because they were loading a truck once a week without charge or keeping records in the receipts book and sharing the profit among

themselves. We arrested the accountant and one of the prison guards and they were fined by the prosecutor brother. The remaining members involved in this action ran away and we are currently looking for them.

15- A group of local Muslims operated one of the inactive wells of the Sector at night and illegally filled up more than a tanker. All of them are from the village of Daman. We arrested them and put them in jail. They are [REDACTED].

16- Another group was arrested for stealing from one of the unguarded inactive oil wells of the Sector. They are also from the village of Daman. They were arrested and jailed.
