Content of Request

To the brother, the wali of al-Raqqah, may God grant him steadfastness. Peace be upon you, God's mercy and His blessings. And as to what follows:

I am sister, [REDACTED]. I'm 30 years old and I have 2 children. My husband's name is Muhammad Judi Nwewi, and his kunyah is Abu Wala al-Tunisi. He is 37 years old, and he has another kunyah, which is Abu Mus'ab Mercedes. He works in the Abu Mus'ab al-Zarqawi Battalion, as part of the maintenance of the brothers' homes.

Eleven days ago, security came to my house and pulled my husband out of the door. His friend Abu Zayd al-Tunisi was supposed to have come to him, but it was security who came. And then a brother came and said, "O Bara, throw me the car keys."

Three days later, the security forces came to us, with my husband in handcuffs, to search the house and in front of my children.

For God's sake, how can a child see his father in this way? This is not the first time that my husband has been arrested by the security forces, and in the end, they say they apologize.

Is it conceivable that this happen to us and suffer the tragedy again?

Please help me in the matter of my husband.

And may God reward you the best.
