borrowed from my neighbor, but they didn't pay me back until now. My neighbor, whom I borrowed from, complained against me for not paying him back his money. This took place two and a half months ago and Abu 'Ahad is a witness on that matter. And may God reward you the best.

All praise is due to God. As for what follows:

A brother came to us and we fixed his car. We said to him, "You bring the materials." He said, "You bring the materials." The agreement was that he brings the materials and we do the labor. Then after we asked him for the money, he got upset, cursed me and insulted me in front of the people.

Other brothers from the Islamic State came by and asked him, "Where do you work?" He answered, "This is none of your business."
