On 10 July 2015, my son, Mu'taz Ali Muhammad Ali was injured in a car accident in al-Tamim Neighborhood in Mosul. It resulted in what is written in the initial medical report numbered (003617) on 10 July 2015 at 11:30 AM. The diagnosis revealed an internal brain hemorrhage. The driver [who hit his son] did not come during that time period and did not offer me help, neither did he ask about my son's health.

As for what to follows:

I would like to clarify the following regarding my injured son, July 2015:

1- No complaint was filed against the driver (the defendant), on the date of the accident, only out of respect because he is from the Islamic State. The initial medical report numbered (003617) was obtained on 10 July 2015 at 11:30 AM. The diagnosis revealed an internal brain hemorrhage. The driver did not come during that time period and did not offer me help, neither did he ask about my son's health. The only thing he did was pay the amount of 1 million Iraqi dinars, which was collected from the sector in which he works, based on the claims of the sector's emir, named Abu Ahmad.

2- According to the initial medical report, which was written by the specialized doctor, my son has to be treated outside of Iraq because the necessary and special materials are not available to treat my son. When I went to the driver (the defendant) (Muhannad Ghanim Ibrahim al-Hayyali), who lives in Suk al-Sha'arin in Mosul, he did not provide [financial] support for the purpose of sending my son out of Iraq for treatment because his health condition is critical and he remained untreated, it will affect his health in the future. He is currently paraplegic.

3- The driver (the defendant) claimed that my son stepped out of the vehicle through the window, while the person who was with him mentioned that my son did not step out of the window, rather, he used the dedicated exit door. The witnesses of my injured son are:

and . He confirmed that my injured son did not step out of the window. Also, my injured son has witnesses who can't speak Arabic because they are from the Turkman ethnicity. The investigator of the accident did not understand their testimonies correctly. Likewise, witnesses of the accident confirmed that my injured son stepped out from the dedicated exit door. They confirmed that the windows of the vehicle were closed and he couldn't step out of them.
