In the Name of Allah, the Gracious, the Merciful

Peace be upon you and God's mercy and His blessings.

All praise is due to God, Lord of the Worlds, and peace and prayers be upon our Prophet. And as to what follows:

To the brother, the Wali of Wilayat al-Raqqah, may God preserve him and straighten his step to be on the right path.

This is a complaint I am submitting to you as a result of the injustice to which I was subjected by the former Emir of the City Education Office, Abu 'Abdul-'Aziz al-Shami, and brother, the City Emir, 'Akrimah.

God Almighty says: (O you who have believed, fear Allah. And let every soul look to what it has put forth for tomorrow).

And says: (And let not hatred of a people incite you not to act equitably; act equitably, that is nearer to piety).

And says: (And he will have failed who carries injustice).

And says: (Think not that Allah doth not heed the deeds of those who do wrong). And says: (O MY slaves, I have made oppression unlawful for myself and I have made it unlawful among you, so do not oppress one another.) [This is not Quran, rather, it is a Hadith in which the Prophet narrated from Allah].

Text of Complaint:

I had been absent from the residence in the headquarters for few days due to health conditions that I have been suffering from for nearly two years. I have a psychological condition that causes me to have nervous attacks and fainting. In addition to a herniated disc in the spine that affects my back and right leg. Also, my wife suffers from nervous attacks and I cannot leave her alone at home all day. This matter forced me to stay at home most of my time in the Wilayah, for there is no one to help her but God, and me, the weak slave. And for your information, her family left the lands of Islam and headed towards the lands of disbelief.

Then, brother Abu 'Abdul-'Aziz submitted 4 reports to the City Emir, stating that I had not stayed at night in the headquarters during the last period.

I was arrested by the brothers in the Special Police [and detained] for 3 days, during which I suffered from nervous breakdown, after which I was sent to the General Hospital several times. Note that I informed brother Abu 'Abdul-'Aziz and the brother, the City Emir about my health condition and that I cannot stay overnight at the headquarters.

Note that I slept at the headquarters during the period of the former official, as I struggled myself to sleep at intervals, and I was committed to my work and I had no problem with the brothers.

It is worth noting that brother Abu 'Abdul-'Aziz, since taking charge of the office, have always denied me and hunted me for mistakes. He accused me of lying more than once in front of the brothers. The brothers testify to that, and you can refer to the brothers in the office and ask them about this matter.

I ask you to do justice to me and remove injustice from me. God is in the help of the slave, as long as the slave is in the help of his brother. Whoever relieves a Muslim of one of the distresses of this world, God will relieve him of one of the distresses of the Hereafter.

I ask you to excuse me from mobilization [maybe he meant to say overnight duty or maybe he didn't want to go to battlefield and his emirs were right about him], as I am unable to do so for the reasons mentioned above.

And may God reward you the best and straighten your steps to be on the right path.
