## 12th members from Jaysh Al Mujahedeen Report

- Al Rabbi is a branch of the Al Jabour tribe from the Arab Al Jabour region of Iraq. Most of them are previous Ba'athist.
- After the occupations, Khalid Dawood, Sheik of the Al Rabbi branch and a former Ba'athist officer in the Iraq Army, garnered a great deal of money by stealing both cash and vehicles from the previous government. He has been communicating with the Americans. He volunteered a large number of his relatives into FPS, ING and the police force. A number of his family members became sources and spies for the Americans. They rode along in Humvee's with the Americans. Among his family members who aided the Americans were "Hammed Al Rakaz-Abu Zahir"; his brother "Mahmud Al Rakaz"; his cousin "Aziz Al Abbas", a sheik for one of the tribe branch's; who allowed his daughter to work as an interpreter with the Americans.
- "Khalid Dawood" became a very important person in the current intelligence agency, but he was assassinated in the Dorah area by the hands of the Mujahedeen brother, thanks be to God. Following his death, we eliminated 65 spies from the Al Ibrahim branch, a section of Al Rabbi. During this time we faced great risk of our Mujahedeen being arrested at the hands of those corrupted from Al Rabbi.
- After "Sayed Malek", the apostate, became the Al Dorah city counsel president, Abu Dasheer employed thousands of workers in a project, paying them a lot of money in return for information about the Mujahedeen's brothers. Then Sayed Malek met with the American sympathizers from Al Rabbi tribe to create a group to fight and eliminate the Mujahedeen brothers. He chose 18 individuals to conduct the mission.
- Once we discovered the names of these individuals, through a person that worked with them, we were able to document confessions from them.
- After their mission failed to eliminate us, they decided to enlist the aid of "Sheik Atta Allah Al Abed Allah Al Rabbi". He is the sheik of an Al Rabbi tribe mosque and later became the Sharia (Law) leader to The Mujahedeen army. He called for revenge of the killing of Khalid Dawood and the other 65 personnel, whom he called martyrs. At his bidding, men from Al Rabbi joined the Mujahedeen army Jaysh Al Mujahedeen) only for one reason vengeance.
- Details about the killing of the 12 individuals from Jaysh Al Mujahedeen:
- The individuals from Jaysh Al Mujahedeen, the corrupted from Al Rabbi, started a brawl with the Mujahedeen of ISI. There are a great number of them in the area and they barricaded the roads against the movement of the Mujahedeen. They communicated with Salah Al Din Battalions, the military army of the Islamic Party, and after a great amount of provocation they planted an IED and exploded one vehicle belonging to one of the brothers from ISI, killing him.

- After this incident, the ISI judge issued a statement banning Jaysh Al Mujahedeen from carrying any weapons during the curfew and up to the court date. There are many who can attest to this ban.
- Two days before the court date, they attacked the area commander, but our brother did not respond. The following day they planted an IED in front of the mosque and the meeting place for the judge and the area commander, but with God's will, we discovered the IED. The same day, there was a great fight and our soldiers, while not ready for the fight or to respond to the attack, moved with 5 vehicles and clashed with them. The outcome was the loss of 12 during the fight.
- After the fight we issued to them the following ultimatums:
- 1. Stop any communications with the Americans and the apostate government.
- 2. Drop all your weapons and stop the fight.
- 3. We have not asked them to pledge to the ISI, despite some of them asked, but we have refused due to them being bad elements.
- 4. They have to obey the current Sharia court.
- 5. ISI will offer them protection and they have every right to representation of any complaint offered to the court.

## Note:

- 1. Some of the brothers from the Islamic army supported and helped the brothers from ISI during a mission. The area Amir decreed they were innocent and not part of the corrupted Al Rabbi. The fight is between the Mujahedeen and the spies and not with Jaysh Al Mujahedeen.
- 2. Al Rabbi declared that all the members of Jaysh Al Mujahedeen are innocent.
- Information about the 12 personnel killed:
  - 1. Saleh Abed Allah Al A'arag—bad reputation, alcoholic, his son and his nephew were killed by the Mujahedeen, due to their relations (TC: Being a source to the Americans) and does not pray.
  - 2. Ali Al-Abd Allah Al-Khalf Al-Rabbi.
  - 3. Adnan Abd Allah Al-Khalf Al-Rabbi.
  - 4. Hisham Kazem Al Rabbi.
  - 5. Amm'ar Nagi Al Rabi.
  - 6. Sadam Nagi Al Rabbi.
  - 7. Salam Abd Al-Khalf Al Rabbi bad reputation and does not pray. Member of the City Council.
  - 8. Taha Muhammad Al Rabbi bad reputation and does not pray. Member of the City council.
