1- All problems should be addressed to the Amir according to the chronology; problems should not be discussed in public in front of people.

2- Speed limit in villages should be 50; while in public roads should not exceed 120.

3- Vehicle driver is the person in charge in terms of cleaning and maintenance.

4- Emphasis on group prayer and remembrance [morning and evening] and to follow the norms for the cause of victory.

5 Sleeping after dawn's prayer is strictly forbidden, this period should be utilized to recite the Quran and remembrance and then to start their work.

6- Security procedure should be followed; weapons must be concealed and should not be exposed in public, appearance in public place for no reason is forbidden.

(Danger of withholding information)

*Those brothers who know about group's weapons or their money and fail to report to the Amir, should remember the verse and saying about dishonesty [Followed by verse from the Koran]

*Reasons for the defeat of the Mujahidin and delay of victory.

5- Non interaction with the civilians in the work place at all.

6- General appearance of the guard, cloth, cleanness and shaving is a must

7- During duty you must stand in the right way and regularly handle the weapon correctly.

8- Futility with weapon among guards is strictly forbidden, as it leads to serious incidents

9- A guard must carry his personal badge always.

10- Immediate notification of the supervisor in case of security loophole or to any of his Aides.

11- When handing over and receiving a weapon, between guards make sure to check the weapon and the tools, in case of any defect, it should be reported to the supervisor immediately.

12- Duty of a guard is to protect the assigned site; as such he is not permitted to take any other assignment.

13- Discussion of work related issues at home or with friends is forbidden, do not describe or point private locations of the company.

14- Good conduct and polite behavior with the guest and employees.

15- To search all those who comes in and to follow search procedure.

16- When a strange person comes, one guard should approach him to find out reason for his visit, the other guard stays in his place ready for any emergency, he must follow the following

A- He should not be allowed to enter at all and the door must be closed

B-Scrutiny of the IDs carried by the individual, confirm the name, the number, and other details in it and the vehicle #.

C- In case of suspicion inform Supervisor's Aide or the supervisor himself.

17- Absence is not allowed. Those who neglect their duty will questioned and held accountable.

18- Follow up employees are responsible for the inspection of all sentry locations specified by our company and in accordance with their responsibilities.



1- Individual affairs guardian in the sector is responsible for counting families of the martyrs, detainees and the wounded and fighter who are active.

2- He should have a representative in each battalion to count and distribute assistance based on its designed plan.

3- To report new developments in the sector to the administrative guardian.

4- He should have primary records containing names of detainees, martyrs, the wounded and active fighters.

Rule of Social Assistance.

Singles:

1- The ration for single fighter is 60000

2- The ration for single fighter with dependence as follows

A – Fighter himself 60000

- B His parents 30000
- C Single sister 30000
- D His brother under 30000

3- Material assistance to a single fighter when getting married is \$ 500.00 to 1000.00 based on Al-Anbar Amir assessment, based on hi financial situation his work and reputation, also should be based on the recommendation of his supervisor.

4- When a fighter dies, \$ 500.00 should be paid to his family through Amir of Al-Anbar according to the priority and order #.

5- His salary should be stopped if he has no dependence

Married. .

- 1- Ration of married individual is 60000
- 2- His wife 30000
- 3- Son and daughter 30000 if she not married also the son should be under 15
- 2- If he is the only one in his family they should be paid as follows His parents 30000 Unmarried sister 30000

C – His brothers under 15 30000

3- Assistance for the sick should be assessed by the Amir himself

Families of the martyrs, detainees and the wounded.

1- The same amount the a martyr get when he was alive, should be given to his family which is 60000 and everyone dependent on him 30000, that includes parents, a brother under 15 or unmarried sister.

2- Detainee families, the same amount when he was not captured and which is 60000 and each individual he was responsible for, 30000 for the parents and a brother under 15 and unmarried sister.

3- The wounded, they should have what the fighter's family gets, also, they should be paid for their treatment.

Employees and the forced out:

Employee who gets paid a salary above the assessed assistance that he gets, will not be paid, he will be paid a difference in case his pay is less than the assistance, example, if the assistance is 200000 and his pay is 150000 he will be paid the difference of 50000.

The forced out:

1- He will be paid a house rent in the area where he settles and the matter will be in the hand of the Amir exclusively.

2- The rent will be the median of the area

3- Amir of the sector will be responsible over them and their living condition.

Rules of the Social Assistance for the members of the Organization.

1- A martyr with sons under 15 for males, however, for the females until they get married they will get 30000 Dinar. In case the parents and his brothers under 15 are dependent on him, each one will get 30000 Dinar and unmarried sisters will get 30000 each.

2- In case one of the group member becomes a martyr \$ 500.00 will be paid to his relatives through the Amir of A-Anbar, names will be submitted and will be paid according to the priority.3- Guardian of the individuals will be directly responsible for the family of the martyr and he should follow their living and health matters.

4- If a brother becomes a martyr and he was single, his pay should be stopped.

5- If a brother is employed and he has a salary more or equal to the dues that he gets he will not be paid, if the salary is less then his dues, the difference should be paid.

6- A brother who lives in a rent house, his rent should be paid based on the rent median.

7- Each working brother should be paid sum of 60000 Dinar, and if he has dependents each should get 30000, provided that males should be under 15 and the females are not married.

8- If a brother is completely devoted to jihad, assistance should be paid to his family if they depend on him.

9- Wounded brothers should be paid cost of their treatment after submitting it to the area guardian.

10- A detained brother will have the same dues as mentioned above

11- A brother who moves from town to town should be rented a house based on the median of rent with furniture if he does not have one and should be a property of the group.

12- A brother who is willing to get married should get between \$ 500.00 to 1000.00 according to his work, reputation and obedience, and recommendation of his boss.

Remarks:

Family of the martyr or a detainee or a wounded or temporarily handicap due to his wounds, will consider if his wife is the one running the house she will be paid her husband's salary 60000 Dinar, if she is with her relatives her husband's money will be stopped [60000] Dinar be it the wife or the family.

Battalion Administrators

All battalions based on the request of the administrative guardian in the sector will appoint its administrator to take care of its affairs and will act as a liaison between the administrative organ of the sector and the battalion.

The applicant must posses the following characters

- Obedience
- Honesty and credibility
- Patience

- Personality
- Commands respect of all
- Good conduct and Character
- Literacy preferably graduates.

He will communicate with the sector's administrator and other administrative sectors.

1- Department of relief and Depots

He will communicate with the guardian of relief and depots in the sector directly or through letters at which the guardian of the relief knows the # of brothers [detainees, soldiers, wounded and martyrs etc] also the # of guest houses and their needs at the present time, relief or food stuff. In case any stuff is received from any guardian specifically for the guest house or a martyrs or etc receipts should be handed over. In which whenever a brother hands over any thing out those stuff, he should sign it mentioning the names of the detainees, the wounded and the guest houses.

[Page 23]

Remarks:

Upon receiving any relief stuff for the guest houses it should be distributed taking into consideration

- A- Sleeping guest houses only
- B- Sleeping guest houses and breakfast
- C- Guest houses breakfast, lunch and dinner
- D- Sleeping guest houses lunch and dinner
- E- Sleeping guest houses and diner

Upon distributing food stuff or other stuff, it should be distributed according to usability of the brothers in those guest houses, or what the guest house offers to the brothers for example, guest houses distributes blankets and beds to them etc. breakfast guest houses will be given stuff like flour, cheese, etc

Lunch and dinner guesthouses should get things like flour, oil and rice etc.

2- Soldiers' chamber department (former individual)

Battalion administrator will communicate with the guardian of soldier's chamber in the sector upon which he will provide names of the soldier, the wounded, the detainees and the dead etc first and foremost. Also, to provide department of the soldier with social information about all brothers, to report all houses that comes under demolition or destruction due to activities of the brother.

-To report a new member who joins the section or the battalion.

-To submit marriage applications on behalf of the brothers.

-Submit applications of transfer, if any brother wants to relocate to any section or another sector.

3- Sector's Islamic treasury (previously finance and accounting)

Wherein contact him to receive any money from him as expenses of the battalion along with handing over receipts as well as other assistance to the brothers (the wounded, the detainees and soldiers, etc)

Also to receive receipt for the number of brothers who will be receiving assistance and to send those receipts to the treasury. In case there is any surplus or shortage the treasurer should be notified.

4- Department of movement and maintenance.

Battalion administrator communicates with the guardian of movement and maintenance in the area or the sector regarding any accident or shortage in the vehicle, while following up vehicles under maintenance without any effect on the boss.

Remarks:

Any letter issued by the battalion administrator should consist of three 3 copies,

1- cc to the sector administrator

2- cc to the concerned department [movement and maintenance, soldier's chamber]

3- Battalion's Amir or person in Charge.

Administrative boss of the Sector

Sector administrators are to supervise all sectors' departments and solve existing problems and find ways and methods to avoid expected problems that are likely to occur.

The required departments of the sector.

- Department of Islamic treasury [previously finance and accounting]
- Department of soldier's chamber
- Department of relief and depots
- Department of movement and maintenance

- Department of Booties

Also, sector' administrator should set up administration in every battalion in which, sector administrator will examine position of each of them and to know the required methods and ways of its implementation and every care must be taken such that it should not get off the subject.

Caution:

Firstly, payment consideration from the budget as it exists in the treasury, and secondly, according to the importance in which the money given to the departments should be divided to:

1- Urgent and important

2- Urgent and not important

- 3- Not urgent and important
- 4- Not urgent and not important

All administrators should send to the treasury distribution of the departments' business according to the four points and with this distribution if there is any delay in sending

Money from the treasury or due to an emergency in order not to cause any administrative confusion in any sector.

No decision should be taken in regard to contracts or to receive any money from a contractor unless permitted to do so by the treasury, with an explanation in the application name of the contractor and nature of his assignment which, he is going to do and the benefits that could be gained. The most important thing whether it has an effect on the work of the brothers, in which military leaders should be consulted, if this work has any role to obstruct the work of the brothers.

- Sector administrators should submit daily reports in regard to the condition of their sectors explained in the appendix.

- Sector administrator will meet with [military, press and legal Amirs Etc] to know their needs pertaining to finance and what the money would be used, for example, personal expenses, to purchase equipment, or pay debts.

- There are some private matters or some of which need an explanation, it should be mentioned in a separate report in details, personal opinions and partiality should be avoided.

- Booty money and contributions [unknown word] should not be touched unless authorized by the treasury.
