Some of the activities listed include computer maintenance, making Jihadi videos, CDs for training, and a letter to the human rights organization regarding detainees. The spending was on computer accessories, mobile phones, rent, and expenditures for the Mujahidin and other related expenses. [TC: more activities and purchases in source].

Monthly Report for the Media [Department]

- 1- A number of computers were maintained and formatted.
- 2- News about the suicide bombing conducted by al-Jazirah Sector in Zamar was published on the internet.
- 3- Several CDs containing Power Point educational program were made and distributed to the brothers.
- 4- A 300 gigabyte hard drive containing archive files was cleaned and organized.
- 5- A laptop computer was formatted and Google Earth program was downloaded.
- 6- A flash drive containing video clips was produced and given to the Security [Department.]
- 7- A Power Point presentation containing videos was gifted to the Military and Security [Departments.]
- 8- Copies of paperwork were reproduced for the purpose of buying a SIM card.
- 9- A CD was produced for a martyr.
- 10- A CD for the late Nashwan was produced.
- 11- Video clips of Shiites were posted on the internet.
- 12- A letter regarding the violation of human rights for the detainees in al-Kindi [Prison] was sent to the Human Rights Organization.

- 13- Reports and video clips were withdrawn from the internet.
- 14- 317 CDs for "Sunni Betrayers" [Possibly a video] and for the speech of Abu-'Umar [al-Baghdadi] were produced.
- 15- Video clips were sent to al-Wisal satellite channel.
- 16- Seven video tapes were captured [Possibly filmed].
- 17- Five flash drives were made for the Religious and Central [Departments] and for the Official.
- 18- Four DVDs containing educational programs were produced and given to the Central [Department.]
- 19- Captured videos were saved on a hard drive.
- 20- A flash drive that contains scandalous acts of the Army and the Shiites was produced and sent to be delivered to the Governor.
- 21- Two 8 gigabyte flash drives containing miscellaneous operations were produced and given to the brothers.
- 22- 25 copies for the photograph of one of the wanted were made and given to the Security [Department.]
- 23- 20 copies for the book "Masari' al-'Ushaq ila-Masari' al-Ashwaq" [TC: "Masari' al-Ashwaq ila-Masari' al-'Ushaq" is written by Ibn-al-Nahhas and considered by many to be the classical treatise on jihad] were made.
- 24- A flash drive that contains scandalous acts of the Army and the Shiites was produced and sent to be delivered to al-Wisal [satellite TV] channel.
- 25- Another copy of the one terabyte hard drive was made.

- 26- "Death Industry" video was produced and the face of the female reporter in the video was blurred.
- 27- An eight gigabyte flash drive was recorded from TV.
- 28-450 DVDs for stories 12+13 were produced.
- 29- 1340 CDs for "Shiites, the Killers of the Sunnis" and "Sunni Betrayers" [videos] were produced and distributed to the following Mosques (al-Arbajiyyah, 'Isa Ibn-Maryam, al-Qadisiyyah, al-Darkazliyyah, and Saddam).
- 30- 10 video cassettes were given to one of the Sectors.
- 31- Books and booklets and amongst them "There is no God, but Allah" and "Kashf al-Shubuhat" [Revelation of Suspicions] were bought and given to the Religious [Department.]
- 32- Books for Da'wah [Islamic Missionary Calling] were given to the group of Mosul, and amongst the books 10 copies of "al-Usul al-Thalathah" [The Three Principles] and excerpts from "Mashari' al-Ashwaq ila-Masari' al-'Ushaq".

Purchases

Computer desk for a computer was purchased for 75,000 [TC: Possibly Iraqi dinar]. School supplies were purchased for 119,000 [Possibly Iraqi dinar] to be sold at the store.

140 of "al-Usul al-Thalathah" [The Three Principles] booklets were sold for 35000 [Possibly Iraqi dinar] to one of the bookstores in An Najafi [TC: Possibly An Najaf].

10 of "Muqtatafat" books were sold for 12,000 [Possibly Iraqi dinar] to one of the bookstores.

Nylon for CDs was purchased for 6,000 [Possibly Iraqi dinar] in order to package CDs so that they look presentable for distribution.

A box of 70,000 CDs was purchased.

A terabyte hard drive was purchased for 125,000 [Possibly Iraqi dinar].

Two boxes of 200,000 CDs were purchased.

Phosphorus for identification cards was purchased for 675,000 [Possibly Iraqi dinar] + 200 USD + 450,000 [Possibly Iraqi dinar].

Three multi-colored cell phones were purchased for 300 USD.

130,000 [Possibly Iraqi dinar] rent money for the store was paid.

Purchase of balance [Possibly pre-paid phone card minutes] for 300 USD to be sold at the store.

362,000 [Possibly Iraqi dinar] for the expenses of the brothers.

95,000 [Possibly Iraqi dinar] to equip a store.

25,000 [Possibly Iraqi dinar] for the transport of the warehouse's furniture to another store.

Total expenses: 2,332,000 Iraqi dinar, and 800 USD which equals 944,000 Iraqi dinar

Final total: 3,276,000 Iraqi dinar
