Detainee [REDACTED] recalls the ISI Amir of Mosul by the names Abu Anas, Anas, Abu Walid, and Walid. Abu Anas arrived in Mosul in the last week of November 2007. Abu Anas took immediate control and began establishing relationships with ISI leadership in Mosul. Abu Anas did a good job; [REDACTED]

[REDACTED] Abu Anas is educated enough to have obtained a Doctorate (PHO or MD). Abu Anas lived in Mosul for an extended amount of time, but based on his dialect; he is from Anbar Province or Baghdad.

Detainee reiterated he saw Abu Arab in several locations close to the al-Ma'ash Market. Detainee saw Abu Arab waiting in front of an unidentified mosque located near the al-Ma'ash market. Detainee also reiterated he saw Abu Arab located in front of store located around the corner of the Ma'ash Market.
