Detainee confirmed a map tracked to an ISI media office in Majmu', Mosul [REDACTED]
[REDACTED] The office is a copy store that contains computers and a copy machine. Detainee was last at the office a few days prior to capture. Khalid and an assistant that Detainee has seen with Khalid at this location previously were at the store. Hakim, an ISI media member also uses this office but was not present. Khalid planned to move this office to another location due to the capture of an ISI media member by CF but the office was still at this location at the time of Detainee's capture. The office is located in a former residence. The residence shares a wall with a similar residence to the east of the residence. The door to the gate of the residence is blue green in color and large enough for people to enter but is not large enough to accommodate a vehicle. The office is one level and contains two small rooms and a bathroom. The best time to catch someone at the office is 1000 to 1200 daily except Friday.

Detainee first met Anas the Wali of Mosul approximately one month ago when Anas came to Mosul to take over for Anmar. Anas was accompanied by Abu Arab who acted as Anas' driver and Abu Hasan, an ISI member of unknown position from the Jazirah area located west of Mosul. Anas came from the Jazirah area but Detainee does not know if Anas was working for ISI in the Jazirah area. Detainee believes Anas is from Baghdad because Anas spoke with a Baghdad accent.

[REDACTED] Detainee met with Anas in the Suq al-Ma'ash market on the day of Anas' arrival. Abu Salim, Anmar and Abu 'Ali were also at the meeting. Detainee spent the night with Anas at Abu Qasim's house [REDACTED] [REDACTED] the day Anas arrived. Abu Azam and Abu Nasar, the Saudi, were also at the house.

Detainee heard on Iraqi television that AAM was visiting Mosul on one occasion. Detainee and the other ISI members laughed at the news. AAM has not visited Mosul or the Mosul area since Detainee became a member in June 2007. AAM would not meet with someone at Detainee's level of ISI leadership. The Wali of Mosul would receive communications from AAM but the Wali would not have access to a meeting with AAM.

Tariq, AKA Abu Sumayah stepped down as the ISI amir of North Mosul a few months prior to Detainee's capture. Abu Sumayah always complained about the ISI and wanted to start his own ACF group called the Dawah al-Jihad. Abu Sumayah was supported by Hajji Hamid, an ISI Sharia member and Abu Bakr ((al-Sabawi)) a military member [REDACTED]. Abu Sumayah was punished by ISI and pushed out of the organization. Abu Sumayah wants to return but he (Abu Sumayah) is currently in Mosul and without ISI affiliation. Abu Mahmud took over for Abu Sumayah and is currently an ISI amir but the north areas are now under the control of the left side. Anas is in charge of overall operations in the north and Abu Ibrahim is in charge of military operations in the north.

[REDACTED] Detainee travels everywhere with his real ID card under Detainee's name and a Waqf al-Sunni ID card. Both IDs were at Detainee's residence at the time of Detainee's capture. Detainee received a small Sony lap top from Harith that Detainee took to Abu Qasim's residence prior to Detainee's capture. The lap top was for Abu Hasan, the Jazirah ISI member. Abu Hasan had requested the lap top and all requests went through Harith. Any ISI member that needed a lap top could request one from the ISI amir. Abu Hasan requested the lap top during the same time frame Anas took over as ISI Wali. Abu Hasan was not at the residence at
