[REDACTED] Approximately one month prior to Detainee's DOC Detainee met Anmar on the street corner located to the north west of Anmar's residence. Detainee saw Anmar walk out of the residence and walk to Detainee's location. Anmar rented the house approximately two months prior to Detainee's DOC and Anmar paid 18 million IZD for a three year lease on the residence. The house is two stories and is located next to the Turkomani Party headquarters. The gate to the residence is on the east side of the property and is possibly black and white in color. There is an ornamental design on the gate. The Turkomani Headquarters is denoted by a blue flag with a crescent moon and star

[REDACTED] Detainee and Anas ate lunch at this residence five days prior to Anas' capture. Detainee met Anas at 1000 in the morning in the market area of Hay al-Sumar. Detainee does not recall the purpose of the meeting but it was ISI related. Anas called a friend who arrived at the market and drove Detainee and Anas to the residence. There were two UIMs at the residence. One UIM in his early thirties was blind due to a recent IED explosion. Detainee does not know if the IED exploded while the UIM was

building the IED or while the UIM was emplacing the IED. The second UIM appeared to be the brother of the blind UIM because their appearance was similar. Anas was very familiar with the UIMs at the residence. Anas spoke the same Baghdad area dialect as the UIMs. Detainee ate lunch and then took a taxi to his (Detainee's) residence. Detainee does not believe Anas lives at the residence because Anas mentioned that he (Anas) lived in the area. Anas also left the house at the same time as Detainee. [REDACTED]
