[REDACTED] aka Hajji Hamada or Hajji Hammadi is involved with ISi administration with the oil group on the right side of Mosul. Detainee has met Hajji Hamada in the past but Detainee's work in the ISi does not intersect with Hajji Hamada's work. Hajji Hamada was in the ISi prior to Detainee. Hajji Hamada was in ISi security prior to being transferred to ISi administration.

Detainee did not call 'Amir Shari'a and tell 'Amir that Jar Allah was to be moved to the right side to take over as right side Military Amir after [REDACTED] Haydar al-Afiri's death. 'Amir called Detainee complaining about [REDACTED] Jar Allah, aka Abu Sa'id meddling in 'Amir's business. 'Amir threatened to quit if something wasn't done about Jar Allah. Abu Ibrahim, the ISi Military Amir of Mosul, told Detainee that Jar was going to be moved to the right side military but Abu Ibrahim said [REDACTED] Safug was going to be the amir not Jar Allah. Detainee was captured prior to Jar Allah's reassignment to a military role. At the time of Detainee's capture Jar Allah was still working as a Shari'a advisor on the left side.

Detainee met with 'Amir Shari'a, [REDACTED] aka Abu Nur, [REDACTED] Abu Iman [REDACTED] aka Abu Sa'ad on the right side of Mosul in the old industrial area on the day Haydar al-Afiri was killed. 'Amir needed a new Shari'a judge to help out on the left side of Mosul after [REDACTED] Abu 'Abdallah, the Shari'a judge on the left side, was captured by CF. Abu Sa'ad, who previously had a Shari'a position on the left side became the Shari'a judge on the left side. Detainee recalls the meeting because it was the only meeting Detainee ever had with 'Amir on the right side of Mosul. Detainee always meets with 'Amir in Hay al-Samar. [REDACTED]

Masud was an ISi military member on the left side prior to the problem between Abu Suamayah and the ISi. Masud supported Abu Sumayah's attempt to separate from the ISi and form a new ACF group. Masud was ordered to step down from his ISi position and is currently no longer working with the ISi.
