- Detainee identified the name of Nazar found in the ledger as an entry for Abu Husayn, the Administrative Amir for the right side of Mosul.

Detainee identified the eyes and the eyebrows as being the same, but was uncertain of the other facial features in the picture. Detainee insisted Abu Khalud is light skinned and heavier than the man in the photograph.

Detainee initially met Abu Khalud al-Suri two months [REDACTED] Detainee has seen him on five separate occasions, but has spoken with him fewer times. Abu Khalud is a leader of a mortar and rocket group operating in Mosul. Abu Khalud reports directly to the Mosul Military Amir, Abu Ibrahim. Detainee heard Abu Khalud operates primarily on the left side of Mosul. Detainee has seen Abu Khalud in the general market and taxi location in Hayy al Sumner. [REDACTED]
