## Content of Request

To the brother, the wali of al-Raqqah, may God grant him steadfastness. Peace be upon you, God's mercy and His blessings. And as to what follows:

I'm sister , I am 29 years old, and I am from Tal Al-Samen. My brother, was 71 years old when he was killed during a raid on his house by the Islamic State on the issue of clans 3 years ago.

My father passed away 15 years ago and we have an inheritance. And my brother Ibrahim was the guardian of the properties. And when he was killed, the Islamic State took control of everything, knowing that the property is not only for my brother, but there are heirs.

The confiscated properties are: a gas station, cars, a car crane, 3 generators, lands, houses, furniture of 3 houses, and 265 sheep.

After 3 years, the Islamic State returned to us a quarter of the property, which were: 122 sheep, house furniture and a gas station. Abu Ahmed Hazima promised that no one would harm us, but 6 months ago, Abu Ahmed al-Furati, who works in the [Diwan of] the Rikaz [Revenues collected from oil and natural gas], came and took 4 fuel tanks.

Every day we go to the brothers in the Diwan of Justice and Grievances and finally we were told that the ruling was issued to restore rights to the heirs and confiscate my brother's property.

But so far, we haven't received anything.

I hope that you will help us and solve our problem, because our affairs have become bad.
