Content of Request

We are the sisters, Umm Salim al-Misriyah, Umm Taqi and she has a child girl, Umm Musa al-Almaniyah and she has a child girl, Umm Ibrahim al-Almaniyah.
We have a complaint against the guesthouses sector.
We, the four sisters, live in al-Firdaws guesthouse, and our residence is two bedrooms and a living room. The house we live in is small, but we do not have a problem with it, and we who live in it agree with each other, praise be to God.
But brother Abu Rima brought a sister to stay with us, despite that he knows that the house is small. The woman he brought to live with us is out of prison, and she is called Umm ‘Abdul-Raouf al-Shami. She was imprisoned for not hearing and obeying and she wanted to join her family in the areas of the Free Army.
The judge required her to enroll in a Shari’ah course because of what she is doing.
We do not want this sister for several reasons: her manners are not good, her way [of dealing with them] is not good, the place is small and her lack of acceptance of anything we say to guide her.
Kindly look into our issue.
