Content of Request

My brother Muhammad al-Sham’s wife was taken with her husband, and she heard her husband getting beaten while she was pregnant and she had a miscarriage because of that.

My brother Muhammad’s car was stolen and the security personnel have its key. He was also carrying the rent of the house, about 8,000, and his internet has been shut down for a month. We asked them for the car key but they didn’t give it to us. We asked them to turn his internet on but they didn’t.

We ask from God first, and then from you to investigate with them.

The messenger of God, peace and prayers be upon him said, “There should be neither harming nor reciprocating harm.”

And we have been harmed when they got imprisoned without any guilt. [I know because] I’m the closest person to them.

Please forgive me, and I ask God to help us and you.

And may God reward you the best.
