The house we live in is my sister's house, and my aunt's husband had rented it from my sister's husband. When my aunt's husband left the house for Wilayat al-Khayr, we lived there since 17 Dhul-Hijjah 17 [18 Sep 2016] because we had sold our house.
Then, the two brothers, Abu Sa'id and Abu Mu'awiyah, came to us and asked us to leave the house, so we told them, "Where should we go? My mom and dad are not here and we don't have a place to stay." Abu Sa'id replied, "It does not matter, go and buy a house for yourself with the money from the house that you sold."
Then, he brought us [men from] the Hisbah to drive us out of the house by force. A brother from the Hisbah raised his hand to me wanting to hit me, so I told him, "Do not lay your hand on me." And the brother said to them, "Carry them to prison." Then, they took us out of the house, and now we don't have a place to stay, me, my mother, and my sisters.
