Summary of the letter or the subject:

In the name of Allah, the Gracious, the Merciful and peace and prayers be upon Muhammad and his family.

We ask God to help you in your work and facilitate for you the reasons for success. And as to what follows:

First of all, let me introduce myself: I am the poor slave, aw, one of those whom God has blessed by joining the ranks of the mujahidin in the Wilayat of Aleppo about a year and a half ago. I was working in al-Faruq Hospital at the beginning of my joining the mujahidin when we were sent by Abu 'Umar al-Misri and Abu Muhammad al-Shami, myself and a team of doctors and nurses to activate al-Faruq Hospital, which was then almost not working. I stayed there for about 10 months as an ambulance doctor under the specialty of general surgery. During this period, I was aware of everything in the hospital because I was staying there 24/7. Then God tested me when a job assigned to me by the wali, Abu Zainab, to be part of a medical committee composed of three people (Abu Suhail al-Sudani, Abu Muhammad al-Shami, and I, the poor slave).

Then, after about two months, the committee was dissolved and I was appointed as the deputy medical officer (Abu Suhail's deputy). In general: the method of my administration was to make sure to follow up on most matters and all small and major complaints myself and to resolve them, if I was able to, otherwise, I would be referring them to others.

This method was not suitable for the brothers at work and they were not satisfied with it. They objected a lot and the problems were not solved and stopped at a certain point. Then, the matters used to be raised to Abu Suhail al-Sudani. As for Abu Suhail, and until few days ago, when I was dismissed from my position, he used to ignore me and did not use me for any work. He was ordering people to return to him and let him make the decision in all matters, even if the matter was not an emergency. For example:

Abu Suhail made the brother Abu Tamim al-Hamawi the commander of al-Faruq Hospital, and agreed with him that it should be his direct command, and he ordered the brother not to consult with anyone in any decision making. And when the brother made a mistake and tried to do things

his way, the brother Abu Suhail fired him and punished him by sending him to a location far from the hospital. And when the mistakes were repeated and I was trying to fix them, the brothers would object to me and reply to me with refusal. Other than that, they would go to brother Abu Suhail and tell him false information. The last incident was that I requested a simple administrative procedure at al-Faruq Hospital, but the responsible brother there refused, and the matter was reported as I was negligent. He, in turn, refused my request as well and sent me to the same location that brother Abu Tamim was sent to as a disciplinary punishment. Currently, and since last Ramadan, I asked Abu Suhail to work with Dr. Abu Sirin (Dr. Hamza) to learn general surgery, in which I made a great stride for more than two years, but brother Abu Suhail disrupted that and sent me to the location mentioned previously. I ask you to continue to learn surgery because of the necessary need for me. [End of Abu Sadiq statement]
