### Content of Request

To the brother, the wali of al-Raqqah, may God preserve you. Peace be upon you, God’s mercy and His blessings. And as to what follows:

I want to inform you, that brother Abu ‘Abdul-Rahman al-Furati and the brothers who work with him in the al-Badu Neighborhood leave the headquarters with weapons, in front of the commoners. Also, while they bring some of the detainees, they appear before the people without taking heed of the spies who may pass through there and the drones that are flying by photographing. And for your knowledge, that headquarters in which the brothers work is filled with the families of the mujahidin and the common Muslims, and these brothers do not know that they may offer the Crusaders a service without realizing it.

Before I complained about them, I advised them, because I did not meet with their Emir, that they should hide their weapons and not park their cars in a way that raises the suspicion that this is a headquarters of the [Islamic] State. Moreover, some of the brothers, may God forgive them, sit on the balcony that may expose Muslims’ honors, who live on the opposite side.

Therefore, I advise you to reprimand the brothers and advise them as you see fit, so that they do not bring harm to Muslims more than they bring benefit. And all praise is due to God, Lord of the Creations.

And may God reward you the best.
