Content of Request

I was in the office of the injured [fighters], then I was transferred to the wilayah Operations Room on 7/6/1438 [6 March 2017]. I stayed about a month, then my emir, Abu Nidal al-Tunisi wrote a transfer memo to me. Then, the wali’s office asked, “What is the reason for the brother’s transfer?” Then they were told, “Because of his frequent absence.” I attached the justification for my absence with the memo, and I was checking the mail to find out the response for more than two weeks, and then the brothers in the post office said to me, “Check with the wali’s office.” Then, the brothers in the wali’s office told me: “Go back to your emir and ask him what happened to him regarding the answer to the question of the wali, may God protect him: (he asks you to specify the exact days and duration of absence). I asked my emir about the matter, so brother Abu Qutaiba al-Hashimi asked, “How many days did the brother commit to his work?” He replied, “Brother Abu Tamim and I know that brother Abul-Darda was absent while he was absent for week.” Abu Nidal said to me, “What do you want?” [end of the page]
