Content of Request

To the brother, the wali of al-Raqqah, may God preserve you. Peace be upon you, God's mercy and His blessings. And as to what follows:

I am the Muslim, one of the subjects of the Emir of the Believers, may God preserve him.

I am a tenant in the al-Dar'aiyah area with a legal contract from the owner of the house located within the territory of the Islamic State. Four months ago, the brothers came from the real estate office and asked me to bring the owner of the house. I brought the owner of the house to the brothers in the real estate and they told me, "Go back to the house," after the suspicion was removed. For a week to this day, the brothers from the Western Sector have come and asked me to vacate the house by force, knowing that the [Western] Sector has nothing to do with these matters because it is within the jurisdiction of the real estate office or the court according to the memo that I have, asking the attorney general of the Real Estate and Kharaj Center. Last Thursday I went to the owner of the house, who lives in the area of Darbat Hadla, and asked him to come with me. He told me, "I am a shepherd, and I have no older sons to take my place." Now, the brothers in the area have asked him to move his camp to a safer place, so he cannot come at the moment to give me the house contract and a copy of his ID. Now, I complain to God and then to you about this situation that the brothers in the Western Sector brought me to, knowing that the brothers started harassing and threatening me, [saying:] "if the house was not vacated, we will file a complaint," [mentioning] that you are covering up for the Awakenings, and God help me.
