- 5- It is forbidden to cross out any word in the statement. To correct any mistake, the following should be writing (but such).
- 6- The names of the defendants, statements and witnesses for the evidence shall be recorded at the end of the statement. The names of those who are to be summoned are transferred to the cover of the internal case, where the clerk fills out the paperwork of the attendance (whether for investigation or to appear before the judge).
- 7- The statement is always sealed with the phrase (and after his testimony was recorded, it was read to him, he approved it and supported it with his fingerprint).
