Request Subject	There is a brother who falsely reported me and slandered me, and I was imprisoned for a day until the brother’s report was verified.				

#### Content of Request

To the brother, the wali of al-Raqqah, may God preserve you. Peace be upon you, God’s mercy and His blessings. And as to what follows:

Brother Abu ‘Iraq al-Ansari went to the Special Police and told them that Abu Qatadah had been abandoning his duty for 8 months and married the widow of a Lebanese martyr. “After his deserting, he became very rich and said that the sister, the widow of the martyr, would come to me and I would meet her at my house during her waiting period.” He also told other brothers that I spoke to her on the phone and that I had a relationship with her before I married her. He slandered me with this false statement and I was imprisoned for a day in the Special Police until the brothers verified this statement. The investigator in the Special Police told me that brother Abu ‘Iraq’s report was false and untrue. I demand that this brother be punished for his slander and false communication.

The brothers in the Special Police verified that I was working and that the money I had was from my family. And they verified that Abu ‘Iraq’s words were all lies.

I, Abu Qatadah al-Shami, demand my right to punish this brother for:

- 1- His false report because I was imprisoned for this report for a whole day.
- 2- The brother should be punished for defaming the sister and saying that she used to come to me at home and his words are not true.

The name of the brother who complained about me is Abu ‘Iraq al-Ansari and he works in the Office of the Wounded.

And may God reward you the best.
