Based on the wali's directive regarding Abu 'Uday Shanan's complaint against the al-Sabkhah police, the brothers Abul-Wathiq al-Ansari and Abu Hammam al-Haili were assigned to study the case and inform us of the result.

Subject: (Complaint against the al-Sabkhah Police)

Case Description:

Abu 'Uday claims that the police do not have the right to arrest at night, and the brothers in the police say that they carried out their duty based on the orders of the prosecutor.

Statements of the parties of the case:

- Brother Abu Yusuf Al-Ansari testimony:

We went, based on an order by the prosecutor. We stood far from the house, and we knocked the horn and shouted, O people of the house. A woman came out, so we asked her to call for the men. I don't remember anyone saying we want to search the house. Then, brothers from the [Islamic] State came and said that the owner of the house is imprisoned. Then we went to another place for a second person who was wanted in the case. It was his uncle, and we brought him with us. So, his son came to the headquarters and said, "Release him today, and tomorrow I will bring him." Brother Abu Wissam said to him, "Take him and bring him tomorrow." And the next day he came. We don't go out [in a duty] except by order of the prosecutor or [if there is] fierce quarrels.

<u>Brother Abu 'Uday:</u> I do not want to add anything to what is written in the complaint.
<u>Brother Abu Jihad/ Chief of Police in al-Sabkhah:</u> My response to the complaint is as attached only.

Visuals [notes]:

1- The brother thought that the brothers made a mistake in their behavior, knowing that they did their job based on order of the prosecutor.

2- Abu 'Uday rushed to file the complaint because he was aggravated by what the women told him and did not verify what really happened with the brothers.

3- Abu 'Uday stated that he wanted to close the case.

4- The brothers did their duty based on a summons order from the public prosecutor, Abu 'Abdul- Raouf, because the wanted persons had not yet attended, after informing them. The prosecutor's office told us about this matter.

Recommendations:

1- Close the case because the brothers did not make a mistake, and brother Abu 'Uday regretted it and said that he wanted to close it.
