Based on the wali's directive regarding [redacted] complaint against the Hisbah, the brothers: Humam al-'Asiri and 'Umar al-Muhajir were assigned to study the case and submit the outcome.

Subject/ Complaint against Abu Mus'ab Humam

Description of the case:

[redacted] claimed that Abu Mus'ab Humam hit him and insulted him when he took him from his house to guide him to his brother-in-law's house.

Testimonials of the parties to the case:

The testimonials of the complainant, [redacted] – Age: 37 – Phone Number: [redacted]

The Hisbah patrol came to my house during dinner time. The door was closed but unlocked. One of them called, "Abu 'Ala," so I went outside. One of them said, "This is the husband of [redacted] sister." Then Abu Mus'ab twisted my arm and hit me on my stomach. Another one hit me with the gunstock, and God knows best. There were two of the common Muslims accompanying him, one of them is [redacted] and the other one is [redacted]. Then, Abu Mus'ab intended to storm inside my house. He kicked the door with his foot and my wife tried to prevent him from entering. The reason they did this is that my wife screamed while she was inside the house, saying, "Leave him alone. He has nothing to do with it." Abu Mus'ab said to me, "By God, I'll make an example of you and 'Abdul-Sattar to the neighborhood." Then he said to [redacted], "I'll give you a rifle and a hand grenade, so if you see [redacted] and this named [redacted], shoot them." Then, after they put me in the van, they said to me, "You either guide us to [redacted] or we'll take you to the prison instead of him." So I took them to his house, but they couldn't find him there. They said to me, "Take us to his brothers' houses so we take them instead of him." So I took them to the houses of two of his brothers and they actually took them instead of him. Once they arrived to the Hisbah, they found that [redacted] was there, as he surrendered himself. [redacted] owns pigeons and has no work but to fly them and play with them.
