He was born in 1982. A farmer. His phone number: [REDACTED] Address: [REDACTED]

After I bought the car from my brother [REDACTED] while he was in the prison, for the amount of 900 thousand Syrian Lira, I had the car for 2 months. Then [REDACTED] came and asked for his car. I told him, pay back the 850 thousand Syrian Lira, then you can take your car back. We went to the car dealer so he could sell the car and pay back what he owes, but the dealers didn't pay him more than 600 thousand Syrian Lira. On the same day, we went to one of [REDACTED] friends, [REDACTED], who lives in [REDACTED] building, the [REDACTED], the northern entrance. [REDACTED] has a brother in Ma'dan, who works in the cars business. He is a partner of [REDACTED] the original owner of the car we are talking about. Anyway, [REDACTED] and I stayed in [REDACTED] house, and while we were sitting, [REDACTED] went down to test drive the car. While he was downstairs, he called for [REDACTED]. He told him, "The car is broken, come down." Then when [REDACTED] went, I stayed in the house. They were gone for 14 minutes, then [REDACTED] came back alone, and told me that [REDACTED] is waiting for you about 100 meters away for the house. When I went down, I couldn't find him. I went back to [REDACTED] and I told him that I couldn't find him. He said to me, "By God, I thought you guys are friends, and I didn't know that he took the car without your permission." I went to my house. Then on the following day, I went to Ma'dan and I saw the car there, with [REDACTED]. I went to [REDACTED] but he wasn't there, so I told his wife that this car is stolen ([REDACTED] stole it). Then I went to [REDACTED] father in Ma'dan. I said to him, "Your son stole my car." His father admitted that he saw the car with his son and that his son is a crook and that [REDACTED] is the one had him involved. I gave [REDACTED] a five-day period to return the car and then I went to the Ma'dan court and I filed a complaint before the judge of Ma'dan, but they did not call for him, despite of me going back for nine...
