Based on the wali's directive regarding [REDACTED] complaint, the brothers: 'Umar al-Muhajir and Abul-Mu'tasim biAllah al-'Utaybani were assigned to study the case and submit the outcome.

Type of the case: A complaint

Subject: Hussein 'Attallah's complaint regarding breaking into his house and insulting him.

First of all, there are previous problems between me and my brother and sister's sons. My son was wanted by the police in a case of theft, and the police had assigned my brother and sister's sons ([REDACTED] and [REDACTED] my brother's sons, [REDACTED], [REDACTED] and [REDACTED] my sister's sons) to arrest [REDACTED]. They told me that Abu Jihad, the police emir, told us, "Whoever seizes [REDACTED] I will give him 10 thousand Lira." Then they watched the house. On one occasion, [REDACTED] and his brother [REDACTED], [REDACTED] and [REDACTED] my sister's sons, attacked the house. I was surprised when they came down from the roof to the yard of my house and started looking for [REDACTED] and dug up the things and revealed the women and their clothes dressed. When I got out of the house, I found Abu Jihad's car about 50 meters away from the house. And they did this (raiding and searching the house) four or five times. Those who entered my house from the Islamic State are (Abu Ali and Abu Jihad). The first time they entered was with permission, he looked and came out, and he did the same the second time. But one time, I came to my house and found Abu Ali with my brother and sister's sons, and Abu Ali brought them into the house and the roof. And Abu Ali was searching the house by himself (without me being inside the house). He was digging up the things and did not return them to their place and they went out. Two days later, Abu Jihad, Abu Ali and a brother from the Hisbah came and politely entered after asking permission and began searching for my son until they found him and arrested him. Here my daughter (the wife of the martyr) spoke and said, "Allah does not accept this, for my brother is innocent." The brother in the Hisbah said to her, "Be quiet, or I should hit you with the wireless device and knock you down." Here, the brother from the Hisbah attacked and said, "You impudent woman." And he wanted to hit me. This was preceded by, and on one occasion Abu Ali came alone and entered by force and began to search the house against my will, digging up women's clothes and turning the bed upside down. After the search, he said to my daughter [REDACTED] the wife of the martyr Abu 'Umar al-Maghribi, "You are [REDACTED] and hiding yourself under the Shari'ah dress of women."

My daughter did not respond. He attacked her and removed the veil from her face. When he saw her, he said, "I'm sorry," and he left. He repeated entry with my brother and sister's sons several times.
