Content of Request
To the brother, the wali of al-Raqqah, may God grant him steadfastness. Peace be upon you, God's mercy and His blessings. And as to what follows:
I am sister $\quad$ I am 50 years old. I am a widow and I have 4 sons, one of whom, al, was killed. He was 17 years old, and his kunyah was Abul-Khuder al-Islami. He was affiliated with the Caliphate's army - the al-Faruq Brigade - the Zaid bin Harith battalion. Brother Abu 'Abdul-Rahman al-Shami killed him by mistake in al-Suwaydah, on the 14th of Jumada al-Ula. I received my son's things and condolences [compensation] from brother Abu Muhammad al-Tamimi, and the amount was $\$ 210$.
The court asked me to file a case for blood money. We raised the case on brother Abu 'Abdul-Rahman alShami, who said that he killed my son by mistake. He [she most likely means Abu 'Abdul-Rahman alSham] was killed some time ago.
I had a support [compensation] on the name of my son and his brothers, and the amount was $\$ 100$ that we were receiving. I went to the office of the brothers in the Caliphate Army in 'Umar Al-Faruq Roundabout, and met with brother Abu Ayman. They told us that the financial brother is not there to pay your bail and come back after a few days. Then we went and they told us that they closed this office and the forms moved to the 'Abbarat Mecca.
So we went to the Martyrs' Office in the al-Hadiqah al-Bayda, and the brothers searched for the name and said, "We do not have this person." They told us to go to the main branch of the Martyrs' Office. So we went to them and they said, "We want proof that your son is a brother in the [Islamic] State." I told them that there is nothing to prove because I had previously given them all the documents and everything about my son, and there is even a case in court for blood money. Today I went to them to see if they had a response, but the office was closed.
Thus, I want you to help me in my request.
And may God reward you the best.
