We inform you that I, brother ‘Adnan Mansur, had been transferred from Wilayat Raqqah to Wilayat al-Khayr. A week after making a request to the Real Estate [center], I received a house key from the Real Estate in the evening, with file number 2100 on 18/5/1438 [15 February 2017], which is attached to the complaint. In the morning, I went to Raqqah to get my things. When I got home, I was surprised that the house I received had been broken into, and the other house that was received by a brother who works with me, Abu Ishaq al-Ansari, by the brother Abu Amin al-‘Iraq, who works in the Rakaz. We went to the Real Estate to find out the cause of this problem, and the case was transferred to the Special Police. They sent a patrol consisting of brothers and sisters to vacate the two houses, but they did not find the brother. The sisters on the patrol talked to the sisters in the house to empty one of the houses until the brother arrived. Then, I started unloading my things into the house. While we were working on unloading the things, brother Abu Amin came carrying his weapon and said bad words with anger and severity, in a way that is not befitting a mujahid, against the brothers in the police.
