I, would like to inform you that I live in my husband's house with my 6 children. My husband lives in Lebanon and the house is divided into 3 houses; two of which are surrounded by the same fence and use common service rooms. I live in the first one and my mother-in-law and my sister-in-law live in the second one. Five days ago, brothers came and lived in the third one without bringing any evacuation or confiscation orders. We, women and children only, live in the house because our husbands don't live with us. The brothers who live in the third house are men only and their house overlooks our houses. We live in villages where our houses are open to each other and it is not permissible for men to live among us. There is no objection to taking the house until my sister returns from travel, but we ask you to give it to a family or sisters, because the situation like this is not permissible. And if you are kind to us, we ask you to get them out of the house. And may God reward you the best.
