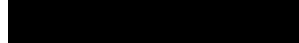

I, [redacted], would like to inform you that I own the house that belonged to my father, who went to Damascus for treatment. I live in it with my wife and I don't have another house except for this one. My father went to Damascus for treatment, through the Islamic State, using his passport. The period has not ended yet and you have [the documentation] attached. Yesterday, came a brother and said that he is a reprehensive of the Real Estate [center], and said that his name is Abu Ahmad. We were visiting [my wife's] family for three days and all our belongings are still inside the house. He broke the outside door and when he tried to enter I prevented him, but he pulled out the pistol and fired and all neighbors can witness to that. Then we went to the police to file a complaint and they transferred us to the Complaints Office.

The request: I ask you to let me live in my house, and may God reward you the best.
