All praise is due to God. After swearing the oath:

The person named Sa'ad came to my house at 4 AM. He started to kick the door with his foot. Then when I opened the door, he started cursing me (my honor and my family), he kicked me with his foot and slapped me on the face. He did that because he sponsored me with the owner of a store that sells foodstuffs for an amount of 290 thousand Iraqi dinars, and I paid the amount of 100 thousand and left 190 thousand dinars. This remaining amount is owed by my brother named [redacted]. The person named Sa'ad threatened me with slaughter if my brother did not pay the amount this afternoon.
