Text of the complaint

I am brother 'Umar Salim Jihad Hasan with the kunyah (Abu Zaynab). I work in Wilayat Kirkuk. Four months ago my brother went to Syria to bring goods. When he arrived to al-Sham Gate, the Security brothers took the IDs of my brother and those with him and kept the IDs with them until their return. When my brother returned, they arrested him while he was carrying cigarettes in his car. His car and the goods were confiscated and he paid a financial penalty before he was released. We did not know that he went to bring cigarettes and God is my witness.

After his release, my brother went to the al-Sham gate to take back his ID, but he was surprised by the Security brothers telling him that his ID is not available. Knowing that the others who were with my brother found their IDs except my brother. He said to them, "Give me anything that can prove my identity or even a replacement." They said to him, "Go away from here or we will put you in the jail." Then, I, as his brother, went to know what happened to his ID. When I arrived to the brothers by the al-Sham Gate, they said to me, "Give us your brother's full name so we can search for it at the headquarters." But they couldn't find it. One of them said to me the exact following words, "Go away from here and never come back. You are making lies against me." My brother said to him, "Fear God." He couldn't take it and he hit my brother. He said to him, "You are a pimp, smuggler and a dog." Then, he forced me and my brother into the gas station and started hitting and cursing us. I asked him, "Brother, why are you doing this and you know that I'm a brother?" He said to me, "You are non-Arab, and it is a shame that you are a brother." Then he grabbed me from my hair and started pushing me in front of the people. He said to me, "I will teach you a lesson in the gas station."
