Subject / complaint

Thanks be to Allah, peace and prayers be upon our Prophet Muhammad, his household, and all his companions...Hereafter:

I am the Muslim woman, Umm-Du'a', wife of Rabi' Abu-Du'a', who works in the ranks of the Diwan of Real Estate and Taxation of the Islamic State [ISIS], Projects and Investment Section of Ninawa Real Estate Center.

My Husband pledged his allegiance since ISIS took over Mosul through Abu-Hashim, a member of Diwan of War Spoils. My Husband is currently still working for ISIS and his father and three of his brothers were killed in their house by the infidels Americans on 28 MAR 2007.

He was arrested for two and a half years in Bukah [phonetic] after this incident. For your knowledge, my husband has three daughters and we live in the area of Kukajli [phonetic]

My husband went on Saturday, 26 of Ramadan to the house of his mother where she told him that she has ovarian cancer and she is going to have an operation at al-Salam Educational Hospital in Mosul to be performed by Dr. Asma' al-Dabbagh. The Doctor gave her an appointment for the operation after Eid al-Fatr holiday and the operation was performed on Sunday, the 5th of Shawwal.

My husband is suffering from several diseases including spinal glide, inflammation of the Kidneys, water bags in the liver, and a psychological disorder.

I have no one I can depend on to look after me, after Allah, beside my husband.

My husband, Abu-Du'a', went on a support mission for ten days starting Sunday 29 of Sha'ban before the Wali [Governor] issued his general calls to arms to all the Diwans. At the same time, my husband submitted a request for time off and explained his situation to brother Abu-Muslim and brother Abu-Sa'id, but the brothers did not give him permission to go with his wife and sick mother who was scheduled to have an operation on the same day.

My husband, in this distressed psychological state and with the refusal of the Emir to give him permission to go and be beside his mother, disobeyed the orders of his Emir and went home leaving his weapon and radio behind. When he arrived home, we had an argument and he left the house to a location unknown to me.

On Saturday, around 24:00 PM, after my husband left his job, the brothers Abu-Muslim, Abu-Hudhud, Abu-Naba', and another person I don't know, raided my house. I was alone with my daughter where they made us leave the house and they searched the house four times. Abu-Muslim asked me to let Abu-Du'a' out or, "we will treat you as the Iraqi Swat team treats people," and I answered him that a member of the Islamic State should not say such a thing, and he answered, "The bastard ran away." I replied to him by saying that I will not accept the way he refers to my husband since he was not imprisoned and lost four members of his family like him. Abu-Hudhud then told the group to leave while saying to me, "Your husband became a rat, I am afraid he was a spy all along and we did not know."

On Monday, After Eid, Abu-Hajir, and Abu-Naba', from the Real Estate Department, came to our house and told my husband to go back to work. The next day, my husband went back to the headquarters at ad Darkazliyah [phonetic], accompanied by my father Abu-'Umar, and he met the brother Abu-Hajir and brother Abu-Harith and the general military official and the general prosecutor. They told my husband to go back to work but he replied saying I will not go back to work with you after what Abu-Muslim did to me and my family. The military official reiterated his demand for my husband to go back to work right away but brother Abu-Harith told him to take some time off for now because of his situation and that he will be summoned when Abu-Musa is back from ash Sharqat.

My husband returned home on the 14th of July.

On 17th of July, Abu-'Arab and Abu-Faruq came to our house and told my husband that they were sent by Abu-Muslim to ask him to come to work. My husband told them that he refuses to deal with Abu-Muslim until Abu-Musa comes back from ash Shirqat.

On Monday, 18th of July, three people entered our house at 24:00 PM, while we and the kids were asleep, and starting to hurl rocks at us. We woke up to the sound of rocks being thrown and came down from the second floor to be startled that they have already made their way into our home without permission. They arrested my husband without letting us know where they were taking him.

I request that you let me know the status of my husband and where he is being detained since he is suffering from multiple diseases.

May Allah reward you.
