I live in my aunt's house, [REDACTED], who works as a teacher. The house is located in al-Shurtah Neighborhood. Knowing that my aunt is outside the Caliphate land. Knowing that the issue of the house hasn't been resolved until now because the investigation paperwork, related to its confiscation, is in the financial judge's possession. The Wilayat Ninawa Education Center has been asked whether the above-mentioned woman left [IS territories] before or after the conquest [of Mosul]. Attached is the memo issued by the financial judge, in which he addressed the Education Center. After I left the house, after I finished praying, the above-mentioned man broke the door and entered...
