We have an agricultural land, which we rented from the Islamic State, and the contract is signed by the two parties: [REDACTED] and Bashir Sultan Hamid. The size of the land is 25 dunums and it was agreed to divide the land. Indeed, the land was divided with the attendance of the brother of Bashir Sultan, named Abu 'Abdul-Hamid and 2 employees from the agriculture [department]. 15 Days later the brothers, Bashir Sultan and Mahmud Sultan, brought workers to divide the land again and without my permission. So I stopped the work. Then they insulted me ...[end of the page]
