Subject / A complaint

I, the Muslims, [REDACTED] with the Konyah Abu Saja, file a complaint against brother Muhammad Jamil Musa with the konyah Abu 'Umar al-Filistini. This man is abusive in the name of the Islamic State. His behavior does not reflect on him, rather, it reflects on the Islamic State. This man is aggressive towards Muslims during his break time. The same does his brother [REDACTED]. He falsely swears that some people smoke cigarettes, while they are innocent. The same does their father, [REDACTED]. We have more than 11 witnesses who can testify on this family. He violated more than 45 families. The complaint [against them] is available in the Military Police. Yesterday, he shot fire, during an argument, and I collected 4 cases of 9 mm Tariq pistol rounds and one case of a rifle round. The police station and the Hisbah are going easy on him, for he gets arrested but hours later, he gets released. Then he says, "I have come to take my revenge from you." I have a brother named [REDACTED]. One time he was on his way to pray in the al-Huda mosque. He stopped him and said to him, "Go pray in Hawd al-Mawrud mosque." My brother told him, "I can pray wherever I want. They are all God's houses." At this point, he dragged my brother, insulted him and hit him in front of all the people. [REDACTED] hit him back, but then, [REDACTED] was arrested and thrown in Kokajli police station.
