Text of the complaint

All praise is due to God and after swearing the oath:

Three days ago, I was arrested by the Abu Sufyan Police Station because of shooting in the air occurred during a wedding party. Before handing me over to the Military Police, brother Abul-Walid pushed me. I said to him, "Do not push me." He said, "Walk, otherwise, I'll hit you." He also said to me, "You are a dog and son of a dog." He said to me, in front of the Military Police personnel, "I would have hit you with a shoe, but I wouldn't do it out of respect for the people around us."
