I, the Muslim, Sa'id Muhammad Nahir with the kunyah of Abu Faisal. I am one of the fighters of the Armored Brigade. I live in al-'Ubur Neighborhood. A brother came to me and told me that a man from the security [department] was at the doorstep of a house and threatening to arrest women and children [of the house]. So I went and asked him not to arrest them until I bring the , who is a relative of mine. I gave him my ID but he man of the house. insisted to take all the IDs of the family members, otherwise, he threatened to bring a mini bus and arrest women and children. I gave him two IDs, then I went to bring my relative, went to the court in al-Faruq street. From there, we headed towards the Islamic Police and had members of the Islamic Police accompany us to search for brother Mujahid, who works at the security checkpoint of the electric station of al-Fath al-Mubin. Then when brother Abu 'Umar asked him where did he get the orders from, he said, "I received an insider radio call to arrest So I asked him while Abu 'Umar was there, "How could you arrest women and children? And where did you get the orders from?" He said and insisted that he had the same orders of the Islamic Police, but I suspected his claims. Then after a short while, one of the common Muslims who entered the house came to the al-'Ubur complaint office and told Abu 'Umar, the Shari'ah official of the Islamic Police that Mujahid found them on the street and he did what he improvised and did what he did without any orders.
