All praise is due to Allah, and after swearing the oath:

Yesterday, at 3 PM, I was driving the person named Salah Taha to the al-Shalalat neighborhood to activate the internet [of his phone]. Then at the academy gate, one of the members of the gate asked to search the mobile devices that we were carrying. So I asked [redacted] "Do you have photos of family members in your mobile?" One of the members of the checkpoint got annoyed by what I said, so he detained me, held me from my neck, said to me, "You are a dog," hit me, spit on me and kept me in the room. Then I was released. One of them said to me, "You should apologize. If [this incident happened] with the apostate army, they would have beat you with the military boat."
