Content of Request

To the brother, the wali of al-Raqqah, may God preserve you. Peace be upon you, God’s mercy and His blessings. And as to what follows:

There is a warehouse of medicines or medical materials located 100 meters to the south of the Faculty of Medicine. The warehouse has an open window on the main road, parallel to the hospital from the east. I informed brother Abu Ahmed al-Shami, the hospital administrator, 3 times a month ago, and he did not do anything. Then, I told brother Abu Hamzah Shannan, who is in charge of the brothers’ wing, and he said to me: ‘There is no use. No one will answer you.’ And I told him: ‘I will bring boxes from the place.’ I told several brothers and went with brother Abu Mujahid Hamdan, who is in the military medical. We brought two boxes containing expensive medical supplies and gave them to Abu Yamen, the administrator of the maternity hospital, and Abu Muhammad al-Shami, the administrator of the general hospital. We put the boxes in Abu Yamen’s car. They told us: ‘We will complain about them and hold them accountable.’ After two days I went and saw the place and it was as is and nothing has changed. Until now, before I come to the office, the window is open. We have to fear God for the money of Muslims, which is the trust and blood of the mujahid brothers. Note that the expiration date [of the medicines] may have expired. Please verify this.
