Q: The brother claims that you are harsh, screaming and your interaction is tough? A: Yes, I shout at my employees after [I warn them] more than once and I know the tone of my voice. As for Abu Luqman, he is a man who is not committed to his work, and everything I order him to do [something], and I say to him, do not leave at a specific time, he disobeys and leave.

Judge Abu 'Ubaydah told me that Abu Luqman is not suitable to work at the court and I was planning to reassign him somewhere else, but because of the changes, I waited until he's fixed in the Wilayah.

As for the brothers who have cases, it is not true that I expel them or shout at them. Q: Are you not committed to the wali's orders regarding working on Fridays and stay overnight at the headquarters?

Yes, we do not work on Fridays, and all judges do not work on Fridays. As for staying at the headquarters, we asked the judge of the wilayah to set up a headquarters for us as judges to meet, but he refused and now I am obligated to stay overnight at the headquarters.

As for the reason why I imprisoned him for a day, I called for him and brother Abul-Walid, but I could not find them. When they came, I asked him where he was. He said: 'I was sitting outside, and then I bought biscuits and came.' I told him: 'this is a time for work and we need you, but we can't find you? You have to abide.' He said: 'I am not in prison, and I will not abide, and this is my nature.' I ordered his imprisonment for not hearing and obeying.

The brother will never work along with me because of his lack of hearing and obedience and his lack of commitment.

What became clear to us about Abu Luqman's complaint against the judge of the soldiers, Abu Mus'ab, is the following:

- 1 Brother Abu Luqman claimed that the judge expels the brothers and shouts at them and is harsh in dealing with the brothers. He mentioned one example, which is the story of the non-Arab. Abu Musab responded that the non-Arab has no business with us, as in his statement.
- 2- Abu Luqman asked for the testimony of Abul-Walid, so we heard from Abul-Walid and he told us that it is not true that Abu Luqman expels the brothers and shouts at them.
- 3- Abu Luqman claimed that Abu Mus'ab, the judge, raises his voice to the workers and shouts and his morals are not good. Abu Mus'ab responded that this is sometimes true, and that his voice is raised because of the lack of hearing and

obedience from him, and that he always opposes and is stubborn, as he described to us his condition.

- 4- Abu Mus'ab told us that Abu Luqman is not very committed to his work, and he punished him with a day's imprisonment when he was stubborn and said: 'I will go out without permission and [I dare you to] do whatever you want.'
- 5- The brother judge told us that at first he did not stay overnight at the headquarters because of their request to prepare a headquarters for the judges to stay there, but the judge of the wilayah refused that. He also admitted that he does not work on Fridays and that all judges do not work on Fridays.
- 6- Brother Abu Luqman is a good brother as we saw him, but the one with him told us that he has epilepsy and is quick to anger, and perhaps this is the reason for his confrontation with the judge. In addition, the judge said that he sometimes raises his voice to them, as Abul-Walid told us. Perhaps Abu Luqman could not bear that.
- 7- Brother Abu Mus'ab, the judge, says that Abu Luqman is not fit for the work at the court, and Abu 'Ubaydah al-Misri also told him.
- 8- Brother Abu Luqman submitted a transfer to the Abu Anas Ibn al-Nadr Battalion (the martyrdom battalion), and the brother wanted to carry out a [suicide] operation, but he says he wrote this complaint as advice [for the sake of] the religion and God.
