Content of Request

To the brother, the wali of al-Raqqah, may God grant him steadfastness. Peace be upon you, God's mercy and His blessings. And as to what follows:

I am the sister [REDACTED]. I am 42 years old. I have been the wife of a prisoner for 12 years and he was taken prisoner by the Nusayri [Syrian] regime because he was a mujahid in Iraq, and his name is [REDACTED]. I have two sons in the Islamic State, one of them was killed and the other is in Iraq and I know nothing about him. My brother's family is all in the Islamic State and they are four families living in one house. We have repeatedly asked the Real Estate [Center] for a house but to no avail. We told the Real Estate that there is a house that has been abandoned for 7 months, but they did not care. There is a phone number at the door of the house. We called him and asked for the house, but the answer came to us that the house belongs to a brother and 'we cannot give it to you.' Then we went to the house and entered it without permission and it had a few things. The same brother that I called came and told us: 'Did I not tell you not to enter the house?' Note that the brother has another house in al-Mansoura. The brother brought with him a brother from the police and asked us to leave the house. The policeman said: 'The brother has the right to sell or rent this house. Knowing that this house belongs to the Islamic State. And when we went and told [it is not clear here who they told] what the policeman said, they said he didn't mean this. Then, brother Abu Rawahah al-Shammari came with his wife and mother and knocked on the door and told us to open the door, otherwise he will remove it. He kicked the door and my niece was behind the door, and she fell on the floor while pregnant and quickly entered the kitchen so that he wouldn't see her. Then, his mother and his wife entered, and he said, 'Let me go in to them, so I can grab her by her hair and throw her out.' We left the house, so they locked the door and went to their house in the city of al-Mansoura. Then, we went to the police to complain about how the door was kicked on us, but the police did not care about us. So, we went to the judge and complained to him, and the judge said: 'You must be imprisoned, but you are women, so you do not have to be imprisoned.' I told the judge he said he wanted to grab the woman who fell by her hair and throw her outside. The judge said: 'You want the rule of Shari'ah? We said yes. He said: 'you should be imprisoned. We, 4 women, were sentenced to 24 hours in prison, knowing that I am the one concerned and my nephew's wife, whom the door was slammed on her, but he sentenced 4 women, not two.
