Content of Request

To the brother, the wali of al-Raqqah, may God grant him steadfastness. Peace be upon you, God’s mercy and His blessings. And as to what follows:

I am sister, [redacted]. I’m 23 years old and I live in Raqqah. I am married to [redacted], he is 38 years old, and he works in Saudi Arabia. He left Raqqa with a permit from the Hisbah two months and ten days ago. I live with my husband’s family in [redacted] with his mother and my two sons-in-law, the oldest of whom is 14 and the youngest is 11 years old, and now they are in Turkey, where my mother-in-law went for treatment because she suffers from a stroke. When the bombing began in Raqqa, I fled to the countryside to live with my family in Rafiqqa Farm until the situation calms down and I go back to my home.

I went back to my house a week ago and found someone living in my house and he is a Turkish brother. I told him I want my house. He said, “There will be a session held in two days, by the Shari’ah court, to resort between us because your husband is an apostate,” and he showed me an old picture of my husband smoking cigarettes.

I returned to him to give me my house, but he did not accept, and he said to me: “You have a second house.” Knowing that I have no other house, and the house in the countryside is my family’s house, not my husband’s house.

The second day, I asked him for my things and begged him to give me my things, but he only gave me (carpets + blankets + gas jar + computer table + our own clothes).

Since a week ago, I’ve been going here and there to have justice restored, but no one answered me, and even my marriage contract was not taken into account because it is not certified by the Islamic State.
